


































2024 marked 60 years since the formation of the SAS Regiment. It also marked 25 years since the Regiment's task force spearheaded the multinational peacemaking taskforce INTERFET into East Timor. A long period of back-to-back operational commitment for the Regiment followed, that saw forces prepared, deployed and rotated across the globe.

While significant military outcomes were delivered, the impact on members and families has been significant. Alongside the Association, Auxiliary and Historical Foundation, the SAS Resources Fund plays a role in somewhat mitigating detrimental impacts.

At the time of INTERFET the SAS Resources Trust was new, having just formed in late 1996. It had modest capital and a specific single remit, which remains the primary purpose of the Fund to this day. However, the consequences of service over subsequent years demonstrated that the National response to the changing needs of veterans and veterans' families often falls short. This has driven the SAS Resources Fund to deliberately evolve.

During 2024 the Fund continued to prioritise support to its primary beneficiary group; the families who have endured the loss of a loved one or individuals and families impacted to the point that they are unable to work. Currently long-term assistance is being provided to 65 Beneficiaries across 27 families.

Circumstances where individuals and families experience temporary financial hardship have continued to appear this year. In most cases the Fund's assistance enables people to get back on their feet, however sometimes temporary hardship transitions to longer-term. Currently, 21 Beneficiaries across 15 families are being afforded temporary relief.

Children who have experienced the loss or total and permanent incapacity of a parent, remain eligible for Fund assistance to age 25, contributing to post-school educational and career aspirations. Since 1996, 20 Beneficiaries have turned 25, including one this year. The Fund does remain accessible to them and assistance has been afforded to some to help with genuine employment or business opportunities.

Currently the Fund is supporting the education of 27 children through school and 9 young Beneficiaries through university. We have valuable scholarship arrangements with several of Perth's private schools, of which we are currently utilising two positions.

The national expectations placed on the SAS Regiment continue to generate a high tempo of capability readiness and commitment. The Fund enabled several welfare and respite activities for serving personnel and families this year.

For many years, we have seen benefit in supporting preventative programs accessed by SAS people, that are facilitated by other organisations and charities. Preventative programmes serve a therapeutic, training or developmental purpose. This year the Fund formalised a biennial approach to considering and supporting such initiatives. This ensures that

assistance is directed to initiatives that are most impactful, directly involving SAS participants and address prevalent circumstances. Some of these are modest ventures while others are significant, involving other well-established charities. Regardless, they all provide needed relief or enable individuals to develop personalised strategies.

The Fund governs the Wanderer's Education Programme, which enables serving members to access tertiary education. This enhances the Regiment's capability, while contributing to an individual's success post service. To date 62 individuals have completed or are undertaking studies in disciplines covering business, leadership, geopolitics, cyber security, psychology, education and physiotherapy. Qualifications span Diploma through to Doctorate levels.

The ability of the Fund to deliver such diverse support stems largely from the efforts of its volunteer Board of Trustees and sub committees, supported by a small and very capable staff. I thank all involved for their energy and commitment over the last year.

I would like to conclude by challenging the paradigm associated with the veteran community, especially as it relates to SAS service. A dominant narrative of tragedy, hardship and vulnerability often prevails.

The accurate narrative, however, is very different. It is one of the proud soldier who is totally and permanently incapacitated but has the courage to accept the toughest of circumstances, step forward and seek assistance for a greater good.

It is one of the bereaved wife and mother, who while faced with the reality of loss, has the devotion that only a mother can, to create the best circumstances for her children.

It is the story of the child who is bereaved or impacted by their parent's service, but grabs the opportunities presented and commits to school, university or vocational training to define their own life.

It is about the serving soldier who seizes an opportunity for advanced education that benefits the ADF, while preparing them for a successful transition to civilian life.

So, the alternative narrative is one of seizing opportunities, optimism, motivation and courage. The Fund is an enabler for these individual virtues to come to the fore.

Finally, I offer my immense gratitude to our supporters over the last twelve months. To the schools, organisations, companies and individuals providing financial and in-kind assistance, the Fund would not be the enabler it is without such caring and loyal sectors of Australian society.

Mark Nidorf stepped down as a Trustee on the 5th of December 2023, negating an opportunity to formally acknowledge him in last year's annual report.

Mark became a Trustee on the 9th of December 2008, making him the longest serving member of the Board at the time of his departure. He was brought onto the Board by the Fund's Founder, Mr Jeff Kazim. This is meaningful because Jeff was extremely considered about who would serve as a Trustee.

During Mark's long tenure, he remained at the very core of what the SASRF does; supporting our Beneficiaries.

As a Board member, Mark's considered mind regularly challenged the status quo, while ensuring the integrity of the Fund, and its associated Trusts, remained true.

He became the Chair of the Assistance Committee early in his tenure and continues to lead this foundation committee as a non-trustee volunteer. He has always brought fairness and consistency to deliberations regarding the many diverse and very challenging scenarios. It is testament to his character that he always expects different situations will arise, rather than living in the paradigm of precedence. As a result, whenever a case without precedence appears, Mark's default is to consider how the Fund may provide support, rather than if it should.

I've personally enjoyed many years working with Mark as a Board member and on the Assistance Committee. I have witnessed his intellect, leadership, objectivity and above all, compassion for the people we are there for. Having his continued involvement is of great benefit to the Fund and very significantly to current and future Beneficiaries.



Mr Rob Druitt



In September, Rob Druitt stepped down as a Trustee having been on the Board since the 24th of July 2012. During this time, he afforded "our cause" the benefit of his significant knowledge, experience and character. His efforts have gone well beyond the "call of duty," not only as a Trustee but as a long-term supporter.

Many of us remember his wonderful assistance, well before joining the Board, running our charity auctions from as far back as 2005. Rob's talents in this regard were instrumental in raising considerable funds in the early days when the Trust was far from flush with resources. I personally remember Rob's ability for squeezing every dollar out of each charity item, no matter its significance. He did so in his signature unique and engaging way.

As a Trustee, Rob has always been "a doer". He has consistently rolled up his sleeves, not only in formal roles, but in promoting the spirit of the Fund to our broad stakeholders and other interested parties.

Rob jumped into the breach as Fund Treasurer; a role he did for several years to an exceptional level. He was also a critical member of the Fund's Governance Committee and has kept an astute ear to the ground about the dealings of our other committees providing advice when warranted.

Very significantly, Rob has taken every opportunity to engage with our Beneficiaries in a very genuine and personal way. As a result, he has endeared himself to those that are at the very heart of our purpose. Rob will maintain an ongoing connection to the Fund's decision making as a non-trustee volunteer on the Assistance Committee.









On behalf of the staff of the Special Air Service Resources Fund, it is my pleasure to present the 2024 Chief Executive Officer's Report for the annual Newsletter.

In my last Report, it was necessary for me to address the series of significant events that have confronted the Fund in recent years. The COVID 19 pandemic, the release of the Inspector General Australian Defence Force Report and the resignation of two dedicated and experienced staff required considerable managerial effort to navigate. It is, therefore, with a sense of contented satisfaction that I can report that 2024 has provided no such challenges and that, as a staff, we have been able to focus more routinely on our core purpose, the welfare of Special Air Service veterans and their families. That does not, however, diminish the year's achievements and the work that made them possible. I must acknowledge the Melbourne Charity Dinner conducted at the Melbourne Cricket Ground which was an outstanding success. Importantly, we were also able to participate and share in the celebration of the 60th anniversary of the formation of the Special Air Service Regiment.

In the past, there have been occasions when the long-term relevance of the Fund has been examined. These considerations have always found, without reservation, that the Fund's mission and purpose are sound and will remain so indefinitely. This year has provided additional evidence that the need for the services provided by the Fund are not just sustained but are increasing. While the trend is not dramatic or alarming, we have again experienced an increase in the number of Trust 1 Beneficiary families. Other ex-service and veterans organisations are also experiencing the same trend. That said I will take the opportunity to discuss two very important projects that may have a lasting impact on the Fund in the near future.

Royal Commission into Defence and Veteran Suicide

The Fund contributed a submission to the Royal Commission into Defence and Veteran Suicide by aligning our views with the National Australian Special Air Service Association.

The Commission presented its final report to the Governor General on 9 September 2024. Many of the 122 recommendations contained in the Report focus on improvements to the process of transition from service to civilian life. To quote directly from the Commissioners' forward to the report;

'... we make many recommendations aimed at preventing harm and supporting early intervention and recovery; improving cohesion, collaboration and coordination in the delivery of support services; building institutional capability and capacity; and improving oversight, transparency and accountability across the ecosystem of agencies and institutions responsible for the health and wellbeing of serving and ex-serving ADF members and their families.'

If successful, the implementation of these recommendations will reinforce the responsibility of veteran care with Government and away from charitable organisations such as ourselves.

Veteran Rehabilitation and Compensation Legislation

The Australian Federal Government has introduced legislation into Parliament to simplify and harmonise the veterans' rehabilitation and compensation framework. This is an important step the Government has taken to respond to the Royal Commission into Defence and Veteran Suicide report. The introduction of this legislation, scheduled for 1 July 2026, has the potential to be very positive for the Fund as delays in the processing of injury claims and the ensuing financial hardship has been a major source of beneficiary expenditure particularly under Trust 2.

Additionally, I believe that through this legislation we may experience an increase in families qualifying

as Trust 1 Beneficiaries by recognition of Totally and Permanently Incapacitated status. The cost of this increase, however, may be countered by a reduction in the financial hardship experienced by these families.

Thank You to Our Staff and Supporters

For the last decade, the Fund has benefited from the generosity of our Trustee, Dr Andrew Forrest, Ms Nicola Forrest and the Minderoo Foundation by the provision of office workspace. Initially and for a significant period of time, at the Sunset Heritage Precinct in Dalkeith and as of February of this year, in Hampden Road, Nedlands, Western Australia. We are very grateful for this continued support that is critical to our operational security.

This year, our organisation has achieved new heights of trust and good-will with all of our stakeholders. This success is due, exclusively and unequivocally, to the capability and dedication of our Operations Manager, Ms Amy Hawkes, and Business Manager, Ms Sonia Baker. Their unwavering commitment and diligent management have been instrumental in ensuring our activities are conducted professionally, sustainably and in accordance with our regulatory obligations. Amy has excelled in navigating logistical challenges, fostering a strong team of volunteers, and creating an environment where Beneficiaries can thrive. Likewise, Sonia has expertly managed finances, strategic planning, and crucial partnerships, allowing us to reach more people than ever before. Their combined efforts have truly strengthened our foundation and positioned us for continued success.

As ever, I would also like to extend my sincere gratitude to our Board of Trustees, Committees, Supporters, donors, and volunteers who make our work possible. Your unwavering commitment to our cause is a driving force behind our accomplishments and success.

As we look to the future, we remain dedicated to our mission and inspired by the potential for growth and positive change. With the continued support of our community, we are poised for even greater achievements in the years to come.

Conclusion

In conclusion, the achievements of the Fund over the last financial year have been ones of consolidation and professional enhancement. I believe we have strengthened our foundation and are positioned to make a lasting contribution in support of a vital national security asset, the Special Air Service Regiment. I remain concerned that as a consequence of the operational commitment to Afghanistan there will continue to be a very significant role for the Fund within the SAS Family perhaps for decades. Nevertheless, I again have full confidence the Fund continues to have the foresight and agility to deal with the full range of possible contingencies.

Finally, I wish to acknowledge and thank our outstanding Board of Trustees. Without their unwavering dedication, visionary leadership, and tireless commitment to our mission, none of our accomplishments would have been possible.

TREASURER'S REPORT 2024

The SAS Resources Fund and Trusts are not-for-profit, charitable institutions registered with the Australian Charities and Not-for-profits Commission (ACNC). The financial reporting period for the Fund and Trusts is from 1 July to 30 June.

As Treasurer I am pleased to advise that the Fund and Trusts continued to perform solidly in the 2024 financial year with an annual growth in investments of around 12%.

In March 2024 we held our Gala Evening at the Melbourne Cricket Ground (MCG) as our main fundraising event. It was decided that an event in Perth would conflict with the Regiments 60th Anniversary Ball which was held in September. The event drew a fantastic crowd and was a great opportunity to reconnect with our Melbourne supporter base, it had been four years since our last event in Melbourne. The event raised \$55,000 for the Fund and \$100,000 for the Wanderer's Education Program. The major sponsor for the evening was Fortescue Metals Group. We would like to thank Dr Andrew Forrest for his continued support.

During the financial year we saw a decrease in beneficiary payments mainly in Trust 2. Trust 2 support is usually not ongoing but involves a one-off payment for discrete purposes. Trust 1 beneficiary payments remained the same as the previous year.

The Wanderer's Education Program (WEP) remained active during the financial year. This is a sub-fund established in 2016 and managed under Trust 3. The program assists members of the Australian Special Air Services Regiment with merit-based higher vocational education, as well as other professional and personal development opportunities to build individual and familial resilience and prepare them for post-service life.




I would also like to mention and thank outgoing Treasurer, Mr Rob Druitt, for his outstanding work and significant contribution to the Fund.


Beneficiary Payments



Income 2024




Expenditure 2024



SAS NETWORK

Integral to our ability to deliver support to current and former members of the SASR and their families, the Fund works closely with the Australian SAS network. This network consists of the SAS Auxiliary, the SAS Historical Foundation, the Australian SAS Association as well as the SAS Regiment.

The Australian Special Air Service Association was formed in the mid-1980s to perpetuate the close comradeship created by past and present SASR members and to provide support to the Regiment. The Association comprises a National Secretariat and State Branches. Membership is an entitlement to all former members of the SAS Company, and former and serving members of SASR. The WA Branch has over 600 members. The Association provides advice and assistance to past and present members of the SAS and their families.

The SAS Auxiliary was formed in 1965 by partners of soldiers serving in the Regiment to give support and promote friendship among SASR families.

This volunteer, not-for-profit organisation, has become a vital component of the Regiment's informal family support system.

The SAS Historical Foundation was established in 1998 to commemorate the remarkable history and heritage of the Australian Special Air Service on behalf of the SASR. The Foundation supports the maintenance of unit morale and esprit de corps through display of military heritage objects that acknowledge the outstanding achievements of the SASR.

Other Units within the Special Operations Command have similar support organisations and networks that are committed to provide direct organic support to their members and families. Regular meetings and forums are held to address issues of importance to ex-service and defence communities.

This network provides vital support to the current and former members of the SAS Regiment and their families.


